**PARKING PERMIT:** Rules and Regulations 2.3 – RVs, Boats/Trailers and all other recreational vehicles and campers are required to be parked in a garage, carport or screened area (as approved by the ACC). A 72-hour parking permit may be obtained from Admin or Security to park these vehicles outside of a garage or screened area on your property.

**NO PARKING ZONE:** SVCA reserves the right to manage its properties and holdings and has established such zones to allow for use of areas while maintaining safety.

Parked in a **FIRE LANE/EMERGENCY LANE** or **HANDICAP ACCESS SPACE:** Rules and Regulations 3.3 and various state and federal laws state that vehicles parked in these areas may be towed at owner expense.

**BLOCKING ENTRANCE:** To building or driveway (fire department/safety regulation).

**IMPROPERLY PARKED:** Rules and Regulations 3.3 and state traffic law do not allow unattended vehicles to be parked in, or protrude into, traffic lanes. Vehicles may be towed at owner expense.

**UNLICENSED** or **INOPERABLE** vehicle **ON SVCA PROPERTY:** Rules and Regulations 3.3 states that such vehicles will be towed at owner expense.
