ARTICLES OF AMENDMENT

TO: Bruce K. Chapman, the Secretary of State of the State of Washington

Articles of Amendment of the Articles of Incorporation of the Sudden Valley Community Club, a non-profit Washington corporation, are herein executed in duplicate by said corporation, as follows:

- 1. The name of the corporation is Sudden Valley Community Club.
- 2. The Amendment to the Articles of Incorporation adopted by said corporation is as follows: Article 1 of the Articles of Incorporation of said corporation, providing that the name of said corporation shall be Sudden Valley Community Club is hereby amended to provide the name of the corporation shall be Sudden Valley Community Association.
- 3. A meeting of the members of said corporation having voting rights at which said Amendment was adopted was held on November 1, 1975; a quorum was present at said meeting, and said amendment received two-thirds of the votes which members present at said meeting or represented by proxy were entitled to cast.
