The owner of each lot or condominium shall have one membership for each lot or condominium owned and shall be entitled to vote on each lot or condominium owned provided, however, that if two or more lots are bound together by an Irrevocable Covenant to Bind Lots and Forfeit Membership(s) in the form prescribed by the corporation's Board of Directors, and in the manner prescribed in the corporation's Bylaws, they shall be deemed to be one lot for the purposes of membership, voting, dues and assessments. Each and every lot owner and condominium owner within the Sudden Valley Deveopment shall be required to become and remain a member of this corporation and be required to abide by its Articles, Bylaws, and Rules and Regulations.
