Typical responsibilities of a sewage system designer can include designing the sewage system, communicating with installers during construction, making additional site visits if problems arise during construction and inspections of construction so that the designer can prepare a record drawing (as-built) of the sewage system. The record drawing of final construction is required for final construction approval and before home occupancy.
