

# Sudden Valley 2024 Valley Fair Vendor Registration Form

The 2024 Sudden Valley Fair will be held on Saturday, July 13<sup>th</sup>, from 10 AM – 3 PM. The Sudden Valley Community Association (SVCA) is committed to producing a quality celebration for attendees with a unique assortment of vendors. If you are interested in becoming a vendor at the 2024 Valley Fair, please review the following information prior to submitting your request.

#### **Details for Vendors:**

- SPACE: All spaces are outdoor, on grass, and approximately 10' deep and 10' wide. You
  must furnish your own tent. Tables and chairs are available for rent from SVCA for an
  additional \$25 fee, subject to availability.
- SUBMISSION OF VENDOR APPLICATION: Submission of application does not guarantee Valley Fair participation. You will be notified by 2:00pm on Friday, June 7<sup>th</sup>, via email of your application status.
- FEES AND PAYMENT: Booth fees are \$50 per 10' x 10' space rented. Fees will be charged after you are accepted on Friday, June 7th, and will be due no later than Friday, June 14th. Fees are non-refundable.
- The SVCA reserves the right to refuse any application for any reason and reserves the right to limit the number of vendors selling similar items or services.
- The Valley Fair is a rain or shine event. There is an indoor facility available in the event of rain; however, it cannot accommodate all planned activities and vendors. The vendor acceptance packet will let you know if your rental can be accommodated in the alternate indoor space in the event of inclement weather. Please note: No refunds will be issued due to weather, due to the forecast of inclement weather, due to the inability to accommodate your booth indoors, or due to any other circumstances beyond our control.
- Booths must be operated Saturday, July 13<sup>th</sup>, from 10:00 AM 3:00 PM.
- Vendors will be pre-assigned booth locations, site access and set-up times.
- Vendors will not be able to tear down prior to festival closing times. Exit times and instructions will be assigned.
- Vendors may only sell what the SVCA has approved in advance.



- We require photos of your products and previous booth setups (if applicable) to be submitted with this application.
- Prospective craft vendors must offer exclusively handmade products. We do not welcome resellers of manufactured or mass-produced items. Vintage items (older than 20 years) are an exception.
- Promotional booth vendors are requested to provide Fair attendees with giveaway promotional items.
- All merchandise and signage must be contained within, or attached to, your booth space.
- No electrical sources will be provided by SVCA onsite, and generators will not be allowed.
- Vendors are responsible for cleanup of their booth space and removal of trash during and after the festival.
- Limited security patrol will be provided by the Association, however the SVCA will not be held responsible for lost, stolen or damaged merchandise. Neither security nor SVCA staff will be tasked with manning your booth if it needs to be left unattended. Vendors who choose to leave items unattended do so at their own risk.
- Vendors will be expected to comply with all rules and procedures provided by the SVCA.
- Booth sharing is allowed if, at the time of application, both vendors provide contact information and product information.

Friday, May 31st: Vendor application due to SVCA by 4:30 PM.

Friday, June 7th: You will be notified via email of your status + key information about the

event.

Friday, June 14th: Payments must be received by SVCA by 4:30 PM.

Saturday, July 13th: Sudden Valley Fair, 10 AM – 3 PM.

You may pay with check, cash, or credit card on or after June 7<sup>th</sup> at the SVCA Welcome Center. Credit Cards payments may be accepted over the phone. Mailed checks received by SVCA after the payment due date of Friday, June 14<sup>th</sup>, may not be accepted and your spot may be forfeited.
